The Local Public Agency (LPA) is responsible for the language in the resolution. The following is offered ONLY as an example resolution that could be used by the LPA with appropriate modifications, for participation in the LPA Federal-Aid program, and is subject to change. The user of this document must ensure that the document as drafted is accurate, complete and meets all requirements of state and federal laws and LPA Guidelines Manual.

NOTE – Before you fill out the Resolution:

If the LPA puts name(s) of personnel in the resolution, they will have to re-do and resubmit the resolution when the named person(s) are no longer with the LPA. That is why the example recommends to Insert the position or positions within the LPA's organization responsible for managing the Title VI – Civil Rights process.
